Judicial Review, former HMS Ganges site, Shotley Gate

As you know, we now have a date for our Judicial Review case into the decision made by Babergh District Council to grant planning permission for 285 houses etc. at the former HMS Ganges site, Shotley Gate. The case will be heard at the High Court in London on 20th and 21st July 2016.

Donations and Pledges

Thank you so very much to all those who have responded to the article in the "In Touch" magazine or the letter that came through your door recently seeking your financial support for Woolverstone PC's Judicial Review application. We are making significant and solid progress towards raising the money needed for our JR costs. But, there is still some way to go.

We have made a great start, but there is more that needs to be done. We need to dig deep and be as generous as possible. If you have overlooked the pledge form, or lost it, please do something about it now. If we win the High Court case - and we have a good chance - our costs will be minimal. If we lose, our costs to BDC/Haylink are capped; additionally we have to fund our representation and court costs. We have to be ready for that possibility, also.

If the Ganges development goes ahead we will see a projected 30% increase in traffic through our village – even more at peak times. Given that these calculations were made five years ago, and also looking at the increasing numbers of vehicles involved in home deliveries on our roads (up 4.2% since 2014), I expect those figure will prove to be an under-estimate.

In addition, Babergh District Council is also promoting the Shotley Peninsula as a tourist destination which, if successful, will see further traffic through the villages along the B1456. Look out for the glossy "Shotley Peninsula" guide in Tourist Information Centres.

I believe our countryside is currently under threat in a way never seen before in our history: planning regulations are being stripped away; councils are being given financial incentives from central government to build more and more houses; developers and their armies of lawyers are prepared to crush local opposition. Surely we cannot stand by and see these things happen?

Please help us to challenge the urbanisation of our unique and beautiful peninsula.
