### **Judicial Review, former HMS Ganges site, Shotley gate**

We now have a date for our Judicial Review case into the decision made by Babergh District Council to grant planning permission for 285 houses etc. at the former HMS Ganges site, Shotley Gate. The case will be heard at the High Court in London on 20<sup>th</sup> and 21<sup>st</sup> July 2016.
